As informed earlier vide intimation dated 25th September, 2020, the Company has fully redeemed all 2500 non-convertible debentures having face value of Rs. 10,00,000 (Indian Rupees ten lakhs only) forming a part of Sub-Series A1 aggregating up to INR 250,00,00,000 (Indian Rupees two hundred and fifty crores).

In terms of the Debenture Trust Deed dated 27th March, 2019 executed between the Company and Beacon Trusteeship Limited ("**Debenture Trustee**"), the following securities created in favour of Debenture Trustee for and on behalf of the debenture holders stands released and of no effect pursuant to the redemption:

- (a) Deed of Guarantee dated 27th March, 2019 executed between Mr. Prem Kishan Dass Gupta and the Debenture Trustee: and
- (b) Agreement to pledge shares of Snowman Logistics Limited dated 27th March, 2019 executed between the Company and Debenture Trustee; and
- (c) Power of Attorney dated 27th March, 2019 executed by the Company appointing the Debenture Trustee as its attorney-in-fact to accomplish the purpose of aforementioned agreement to pledge shares of Snowman Logistics Limited dated 27th March, 2019.

The Company has received a letter dated 13 October 2020 from the Debenture Trustee confirming that the above mentioned securities stand released and of no effect.
