4.1 Agency

The Company had appointed **Central Depository Services** (India) **Limited** (CDSL) as the agency for providing the remote e-Voting platform.

4.2 Remote e-Voting

Remote e-Voting platform was open from 9:00 a.m. on Monday, 19th September 2016 to 5:00 p.m. on Wednesday, 21st September 2016 and members were required to cast their votes electronically conveying their assent or dissent in respect of the Ordinary and Special Resolutions, on the remote e-Voting platform provided by CDSL.

5. Voting at the AGM
